### **Flea Market Rules and Regulations--Effective January, 2010**

**Weekend Inside Space costs: All spaces must be prepaid by 1<sup>st</sup> of the month or spaces will be forfeited.**

10' x 10' Flower building	\$20.00 (No 1 day rentals)
10' x 10' 4-H Building	\$20.00 (No 1 day rentals)
10' x 10' Exhibitors Hall	\$20.00 (No 1 day rentals)
Angled corners Exhibitors Hall	\$20.00 (No 1 day rentals)
Electric	\$ 5.00
Table Rental*	\$ 4.00 each per weekend
Camping	\$15.00

### **Outside Space Costs**

20' Frontage	\$10.00 per day or \$16.00 per weekend

**Vendors who do not have their space set up by 8:30 A.M. Saturday will forfeit their space.**

If you choose to share a space with another dealer (you vend Saturday and they would vend Sunday), it will be your responsibility to locate that person. The dealer who signs up for the space originally is the person whom we will collect the full amount from.

**A Full payment is required to hold your inside space(s) for the following month by the 1<sup>st</sup> of the Month.**

**No cancellation refunds or credits given after 9:00 A.M. Thursday of show weekend. Chairman reserves the right to make exceptions.** Payment must be made in Full by using one of the following methods:

1. You may make your payment in person at the Fair Business Office on Friday from 9:00 A.M. until 3:00 P.M. which is located across the fairgrounds at 712 North Street, Suite 101. You may leave payment with a space reservations form at the lunch stand or mail them to the office. You may also call the Fair Office at (419) 332-5604 to make an appointment to set up payment.
2. You may mail your payment "postmarked" no later than the last day of the month to keep you space for the following month:

3. Unreserved inside space will be assigned on a first come first serve basis.

The State of Ohio requires all Flea Market vendors to have the proper vendors license with them. Please call your County Official for rules regarding these licenses.

**Dealers with reserved paid inside space MUST be in place and set up by 8:30 A.M. Saturday or Sunday** or payment will be forfeited and the space will be given to the next person on the list. No vehicles permitted inside the buildings, after unloading, vendors are asked to please move their vehicles away from the buildings so the customers may park closer to the buildings.

Absolutely no solicitation. Dealers are to stay inside their paid space, no advertising will be allowed outside of vendor space. (No signs to be placed at gates, entrances, or anywhere except in your area.) This is a city zoning law.

No loading before 3:00 P.M. Sunday unless permission is given by the Chairman and/or committee.

Buildings will be locked at 7:00 P.M. on Friday and at 4:30 P.M. Saturday. Buildings are to be empty no later than 5:00 P.M. Sunday.

**Each dealer MUST take their empty boxes and trash with them.**

Outside:

Outside Set Up times: Friday 8:00 A.M. – 7:00 P.M.

No Thursday Set-ups or marking space off! No exceptions.

Saturday 7:00 A.M. – 9:00 A.M.

Any dealer attempting to “save his space” prior to designated set-up times by roping or marking off any space will have said items removed and disposed of per the Chairman and the Committee.

White lines on the road mark 20’ frontage.

**Miscellaneous:**

Overnight camping is available at the cost of \$15.00 per night. Anyone including dealers staying overnight in a RV, or camper on the fairgrounds is considered a camper according to state regulations. Anyone staying in their car/van who plugs in will be charged the \$5.00 electric fee. You MUST come to the Flower building to sign in and pay. You will then be placed on the grounds by one of our staff. The Sandusky County Health Department has specific rules, which must be followed in order for us to keep our flea market camping, so please comply.

If you are bringing a pet (both inside and outside dealers), you MUST come to the Flower building and register that pet at the time you sign in. All dogs/pets brought must be secured behind your booth and cannot be in any walkways. Only two (2) dogs are permitted in each 10 x 10 space (this includes puppies you may be selling), and are not allowed near the food concessions. Any animal not secured will be asked to leave the grounds. This is to comply with the Health Department Rules in reference to any animal bites.

**NO SMOKING IN ANY BUILDINGS!**

**No open flames allowed in any inside or outside space. This is a safety issue. This includes candles, incense burners, etc.**

The chairman and/or flea market committee members have the authority to refuse/evict any person for language, obscenities, and/or inappropriate actions.

Dealer agrees to be responsible to collect and report all appropriate sales tax to the proper Ohio taxing organization. The association shall not collect a percentage on sales nor is responsible for dealers complying with Ohio sales tax laws.

The Sandusky County Flea Market/Sandusky County Agricultural Society is not responsible for accidents, damage, loss or stolen property.

The Flea Market Management reserves the right to stop the sale of any item felt not to be in the best interest of the public; refuse any setup, which is not felt to be in the best interest of the Flea Market.  
The Flea Market Management will settle any dispute.
