

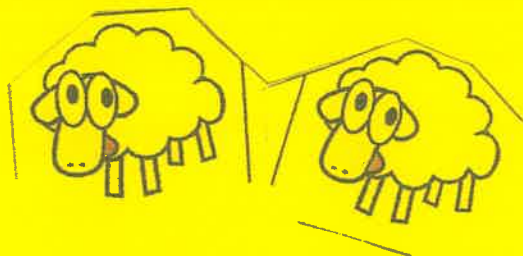
LAMB SCRAMBLE RULES

Animal Scramble Will Be Held at the Horse Arena
Admission is Free.

Last Day and Time to Sign Up for the Lamb Scramble Is:
Wednesday, August 26th, 2026 At 12:00pm - Noon

1. Entry Fee is \$10.00 for each participant.
2. Lamb Scramble is for applicants 8 to 14 years of age.
3. Release form must be filled out completely and signed by a parent/guardian.
4. Shoes or Boots must be worn while participating.
NO flip flops or sandals. NO Bare Feet!
5. Check in starts at 5:00pm at the **Horse Arena** Announcers Stand.
Participants will receive their shirts at this time.
6. Participants will be given a rope halter before entering the Horse Arena.
7. At NO time can the rope halter be used as a lariat.
8. At NO time can the participant tie the rope halter to any part of their body.
9. If participant has hold of the Lamb, NO other participant will be allowed to touch the Lamb until it breaks away.
10. If two or more participants catch the same Lamb, the Lamb will be turned loose.
11. Participants must secure and properly halter the Lamb.
12. A winner will be indicated by Beagle Boy Referees.
13. NO undue roughness or poor sportsmanship will be tolerated.
