Animal Scramble Will Be Held at the Horse Arena
Admission is Free

Last Day and Time to Sign Up for the Calf Scramble Is:
Wednesday, August 26th, 2026 At 12:00pm - Noon

1. Entry fee is \$10.00 for each participant.
2. Calf Scramble is for applicants 15 to 18 years of age.
3. Release form must be filled out completely and signed.
If participant is under the age of 18, it must be signed by parent/guardian.
4. Shoes or Boots must be worn while participating.
No flip flops or sandals. No Bare Feet!
5. Check in starts at 5:00pm at the **Horse Arena** Announcers Stand.
Participants will receive their shirts at this time.
6. Participants will be given a rope halter before entering the Horse Arena.
7. At NO time can the rope halter be used as lariat.
8. At NO time can the participants tie the rope halter to any part of their body.
9. If participant has hold of the Calf, NO other participant will be allowed to touch the Calf until it breaks away.
10. If two or more participants catch the same Calf, the Calf will be turned loose.
11. Participants must secure and properly halter the Calf.
12. A winner will be indicated by Beagle Boy Referees.
13. NO undue roughness or sportsmanship will be tolerated.
