Preparation has begun for our 14th Annual Sandusky County Fairgrounds Winter Wonderland and we would like you to join us! Last year's event was again a huge success for the community and all that were involved and we look forward to making this year's even better.

Last year, we were committed to the safety of our visitors and opened our gates for 15 nights of drive thru viewing. In 2024, more than 4,000 cars passed through the gates and a variety of food items were collected and donated to the Sandusky County Food Pantry! This summer we also continued our scholarship program, offering \$3,000 to two individuals for the 2025-26 school year.

The committee would like our community and the businesses of Sandusky County to be involved and showcased during this event. We are asking for your help in bringing our community together for this family-oriented -holiday event. This year the Committee has decided to offer two weekends of Walk Thru evenings during our Drive Thru event. We will still offer a small token of appreciation to all visitors each night (candy, cookie, hot chocolate, crafts, kids' books etc)for those who join us this year! The Winter Wonderland will begin on Monday, December 8th and run through Monday, December 22nd. Gates will be open for from 6-8:00pm for drive thru and this year we will be hosting 2 days of walk thru on December 19th & 20th from 6-9:00pm. Admission to this year's event will be \$5 per vehicle (drive thru nights)or \$2 per adult on walk thru nights. We will also be accepting food donations for the Sandusky County Food Pantry.

The displays may be lighted, include movement or just a holiday scene. This year we will be asking guests to vote for their favorite display.
