Admission is Free

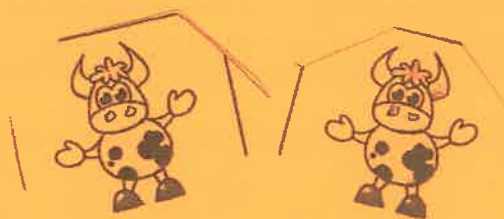
Gentlemen! 19 Years and Older!

1. Entry Fee is \$10.00 for each participant.
2. This Calf Scramble is for all applicants 19 years and older.
3. Release form Must be filled out completely and signed.
4. Shoes or Boots must be worn while participating.
No flip flops or sandals. No Bare Feet!
5. Check in starts at 5:00pm at the **Horse Arena** Announcers Stand.
Participants will receive their shirt at this time.
6. Participants will be given a rope halter before entering the Horse Arena.
7. At NO time can the rope halter be used as a lariat.
8. At NO time can the participants tie the rope halter to any part of their body.
9. If participant has hold of the Calf, No other participant will be allowed to touch the Calf until it breaks away.
10. If two or more participants catch the same Calf, the Calf will be turned loose.
11. Participants must secure and properly halter the Calf.
12. A winner will be indicated by Beagle Boy Referees.
13. No undue roughness or sportsmanship will be tolerated.
