This event will be open to the public and admission will be \$5 per car (drive thru nights) or \$2 per adult (kids under 12 free on walk thru nights). Donations will also be accepted for the Sandusky County Food Pantry.

Events will be planned during walk thru hours on Fridays and Saturdays only, which will include craft show, horse rides, refreshments, kids crafts and activities and **Santa!**

As a participant you will be responsible for the following:

1. Providing all materials for a Lighted Display or Holiday Scene.
2. Outdoor display set up will begin November 18th. **Displays must be completed by 5pm on the December 8th.** Displays can be taken down after December 26th.
3. **INDOOR Displays** can be set up between 8-4pm weekdays after November 27th or by making arrangements for evenings from Dec 4th – 7th.

You will be provided:

1. An electrical outlet for your display (not responsible for additional extension cords).
2. A minimum of 30-40 feet for a display (depending on location indoor/outdoor).
3. Security during the event, but is not responsible for anything damaged, lost or stolen. The fairgrounds will be locked when the wonderland is not open to the public.
