Entry fee \$10.00. Limit one entry per exhibitor.

Exhibits must be weighed in on Sunday, August 21, 2022, from 3 p.m. to 7 p.m.

Judging: Tuesday, August 23rd at 9:00 a.m.

GILTS AND BARROW ARE ALLOWED.

The Sandusky County open market hog show will be open to residents of the State of Ohio. However, to be eligible to enter, the residents' home county must have an equal-type hog show for the Sandusky County residents to exhibit.

Market Hog Show Rules.

1. *Market Hogs will be weighed in on Sunday, August 21st, 2022 from 3 p.m. to 7 p.m.
2. All Entries will be divided into lots after Weigh-Ins on Sunday, August 21st, 2022.
3. All exhibitors are limited to one entry. Exhibitor must own their Hog for at least 60 days prior to fair.
4. There will be a live weight limit (200-265#). No tolerance will be allowed to Exhibitors in qualifying Hogs.
5. Entry fee shall be \$10.00 (includes \$5.00 Jackpot Show, \$3.00 trucking fee, and \$2.00 for Ear Tags/Pen Fees). All pens are to be put back in place. Entries will be made through Sandusky Co. Agricultural Society.
6. Premiums for Live Show are as follows: 1st-\$12.00; 2nd-\$9.00. 3rd-\$7.00 The same premiums also to be paid for top three placings overall.
7. All hogs will be marketed, this is a terminal show.
8. Due to changes in packer/market requirements, all swine exhibited at the Sandusky County Fair will be Ractopamine Free. Ractopamine free means from the time of birth to the time of market. Ractopamine is sold under the trade name of Paylean or Engain for swine. A signed affidavit from the exhibitor, parent, or legal guardian will be required.
9. Only ONE Hog per exhibitor will be weighed. NO EXCEPTIONS.
10. Any extra hogs brought to the Fair will be charged a \$25.00 fee per hog.

11. Senior Fair: A \$50.00 pen fee will be charged for open class entries that are not weighed and exhibited. The pen fee will be waived if the swine committee is notified of the entry cancellation prior to pen assignments. Pen assignments will be done the Tuesday prior to the start of the fair
12. Pens will be assigned to each exhibitor by the swine committee. Pens will be grouped by family, when possible, with a maximum of 2 entries per pen. No animals will be allowed to be moved around the barn.
13. Only water may be used. Any oil or what appears to be oil or powder will not be permitted for Open Class Market Hog Show.
14. Any Market Hog disqualified will be sold to a base bid less \$50.00
15. If an exhibitor cannot verify that their market hog is free of drug residue, it is not eligible to come to the fair. Any market hog found to have drug residue per USDA/FSIS, will be condemned, and all money forfeited.
16. The Sandusky County Agricultural Society, Ohio State University Extension (4-H), FFA, Boy Scouts, Girl Scouts, and all involved in the Sandusky County Fair support a code of good sportsmanship in all events and promote learning and responsibility through its activities. Verbal abuse, physical abuse or harassment toward directors, judges, ring stewards, superintendents, employees, OSU extension staff, Junior Fair members, club advisors or volunteers of the Sandusky County Fair will not be tolerated. You may be escorted from the fairgrounds; premiums forfeited, and upon Sandusky County Agricultural Society Rule Committee's decision, the family members may not be able to exhibit at the Sandusky County Fair for a period of time, indicated by the committee based on the severity of the situation.
